Bidders:

The undersigned, as Bidder, hereby declares that the only person or persons interested in the Bid, as principal or principals, is or are named herein and that no other person than herein mentioned has any interest in the Bid of the Contract to which the work pertains; that this Bid is made without connection or arrangement with any other person, company, or parties making a bid or proposal and that the Bid is in all respects fair and made in good faith without collusion or fraud.

The Bidder further declares that he has examined the site of the Work and, through personal knowledge and experience and/or subsurface investigations, has fully satisfied himself in regard to all conditions pertaining to such site and Bidder assumes full responsibility therefore; that Bidder has examined the Drawings and Specifications for the Work and from his own experience or from professional advice that the Drawings and Specifications are sufficient for the Work to be completed; that Bidder has examined the other Contract Documents and all Addenda relating thereto, and that Bidder has satisfied himself fully, relative to all matters and conditions with respect to the Work to which this Bid pertains.

The Bidder proposes and agrees, if this Bid is accepted, to contract with York County Government (OWNER) in the form of contract specified, to furnish all necessary materials, equipment, machinery, tools, apparatus, transportation and labor and to perform all work necessary to complete the Work specified in the Bid and other Contract Documents. The York County Regent Parkway Sanitary Sewer Relief System Project is being funded in part by the SC Rural Infrastructure Authority Basic Infrastructure Program.

The Bidder further proposes and agrees to commence substantial work on this project within **14 days** of a Notice to Proceed and agrees that the Work will be substantially completed **336 days** of the Notice to Proceed, and completed and ready for final payment **366 days** of the Notice to Proceed.

The Bidder further agrees that the deductions for liquidated damages, as stated in the Agreement and General Conditions, constitute fixed, agreed, and liquidated damages to reimburse the OWNER for additional costs to the OWNER resulting from the Work not being completed within the time limit stated in the Contract Form. Liquidated damages shall be addressed as follows:

- A. For failure to achieve Substantial Completion by the contract date: \$500.00 per consecutive calendar day.
- B. For failure to achieve Final Completion by the contract date: \$500.00 per consecutive calendar day.

The Bidder further agrees to execute a Contract and furnish satisfactory Performance and Indemnity and Payment Bonds, and the required Certificates of Insurance, within ten (10) consecutive calendar days after receipt of Notice of Award of the Contract, and the undersigned agrees that in case of failure on his part to execute the said Contract and Performance and Indemnity and Payment Bonds within the ten (10) consecutive calendar days after the award of the Contract, the Bid Bond accompanying his Bid and the money payable thereon shall be paid to the Owner as liquidation of damages sustained by the OWNER; otherwise, the Bid Bond shall be returned to the undersigned after the Contract is signed and the Performance and Indemnity and Payment Bonds are filed.

Note:

All work performed by the Contractor as essential to the completion of the intent of the Contract Documents shall be paid in accordance with the Bid Schedule. No direct payment will be made for work performed which is not shown as a separate Bid item. The undersigned proposes the following unit prices to be utilized on the Work or Extra Work should modifications or variations incorporate these items of work into the Work.
